# Board of Regents approves revisions to Regents Rule 03.900, Delegation of Authority for Contracts and Agreements

The UNT System Board of Regents met on Thursday, May 18, 2023, and approved several major revisions to Regents Rule 03.900. Under the revised rule, Board approval for contracts was amended to reflect requirements for current fiscal year and multi-year contracts. The Board also set new requirements for UNT System Administration and Institutional oversight and administration of contracts.
